BOW MAR PUBLIC WORKS Driveway Permit Application Street Cut/Right of Way Permit Application

Bow Mar Municipal Code, Chapter 11 requires a permit to cut pavement or excavate right-of way materials or construct any means of entrance (i.e. driveways) to the road in the Town of Bow Mar. Chapter 11 also requires a permit for the construction or replacement of driveways. Penalties are provided for violations of this ordinance (Sec. 1-72). All Town Code requirements must be followed including contractor license requirements, working hours allowable, equipment onsite, etc.

NOTE: Incomplete applications may not be considered by the Public Works Department. To ensure your application is considered, complete the entire application and submit all required materials.

A Permit Fee of \$400.00 plus a minimum inspection fee of \$200.00 and all applicable engineering fees, bonds, etc. must accompany the submission of this Application. Please allow at least one week for issuance of a Street Cut Permit or Driveway Permit.

Bonds, Insurance and Inspection Requirements:

- 1. Identification of \$5,000 performance bond good for one year
- 2. Completion deposit or letter of credit attached
- 3. Evidence of insurance (liability, workers compensation and motor vehicle)
- 4. The permit and engineering/inspection fee for this permit will be a minimum of \$600.00 payable to the Town of Bow Mar. Your check must accompany this application. Further expenses may be incurred if additional inspections are needed.
- 5. Contractor will provide traffic control in conformance with the current edition of the Manual on Uniform Traffic Control Devised (MUTCD). A traffic control plan showing traffic control devices to be used and their location must be submitted and approved by the Town before work begins.
- 6. A 2-year warranty is required for all work in the Right of Way.

Special requirements for roadways newly paved within the last 2 years:

1 –Asphalt Replacement is to be <u>Full Depth</u> of the street that is cut.

2 - Infra-red patches are required 1' foot past the perimeter of the patch or road cut.
